## 1. MATTERS ARISING FROM PREVIOUS MEETING

- *Membership Matrix* Stephen D would write to each Delivery Group chair to ask if their current membership was meeting their needs and if not, what actions would be taken to fill any geographical and sectoral gaps.
- Innovation and Internationalisation Delivery Groups chairs had now been appointed.
- Governance Structure a summary of FC's governance structure was circulated to the Group in September.
- *Ministerial Business Breakfast* Representatives from each of the Delivery Groups attended the breakfast. Discussion on the proposals for 2018 was deferred to the end of the meeting.
- Eden Campus Simon Wallace (SE) had been asked to make contact with Derek
  Watson. Quarterly meetings were to be arranged between SDI, FC and the University.
- SE contact for ESES City Deal Ian Blewett (SE) is assisting with the final business case for the Industrial Estates Regeneration Programme.
- Innovation Engagement Activities Hugh Hall had joined the Innovation Group and the action to develop a programme of activities had been passed to the Group.
- STEM Action Plan would be presented to the Group at a future meeting.

# 2. OPERATIONAL ISSUES

# Delivery Group Membership and Activity Update

An update of each group's activities had been circulated previously. Robin commended how well the groups were going. He highlighted the new 'Delivering Differently' project targeting employability support to people with mental health issues. The need for more investment in innovation and internationalisation was stressed.

### BiFab

Danny Cusick informed the Group that a solution had been secured to avert the company's immediate closure and work was now being carried out by SE, the Scottish Government and BiFab to secure a long-term solution.

#### 3. IMPLEMENTING FIFE'S ECONOMIC STRATEGY

#### **Investment Theme**

Colin Brown gave a presentation on the group's membership and meetings held to date. He outlined some of the investment-related issues facing Fife including competition with Glasgow and Edinburgh and negative publicity. It was agreed that the Partnership had a role in helping communicate positive messages about Fife to opinion makers.

# The Fife Partnership's Plan for Fife

Robin Presswood outlined the newly approved Plan for Fife. He explained that the new Plan was closely aligned to the priorities of Fife's Economic Strategy (FES). Governance arrangements for the Plan were still to be agreed; these may involve changes in the way in which the FEP connects with Fife Partnership. A briefing reviewing the alignment of FES and the Plan for Fife would be circulated to members.

# Edinburgh and Tay Cities City Region Business Leadership Proposals

Gordon Mole informed the group that both the Edinburgh and Tay Cities City Region Deals were looking for nominations for respective Business Leadership Fora to provide advice, oversight and steerage. It was agreed former FEP members would be suggested; Robin Presswood and Stephen Doran would draw up short-lists.

It was agreed that a FEP communications strategy would be discussed at the next meeting.

## 5. MINISTERIAL BUSINESS BREAKFAST

Stephen Edmiston explained that whilst the November business breakfast was well organised and attended, there had not been enough time for discussion.
